

What do you need to know?

At ICAEW, we offer the ACA qualification, which is highly respected in the business world. Other accountancy bodies will award different letters and titles, but to use the letters ACA after your name you must complete an ACA training agreement.

BECOMING CHARTERED - THE PROCESS



AREN'T ALL ACCOUNTANCY QUALIFICATIONS THE SAME?

No. The qualifications offered by accountancy bodies differ both in terms of their content and career focus. Likewise, the level of support you'll receive during training varies between accountancy bodies. At ICAEW, we pride ourselves on providing a high level of support (and not just during your training, but throughout your entire career as a qualified chartered accountant). What's more, the evidence shows that the ACA is an excellent qualification for business leadership.

HOW TO APPLY

Many employers offer ACA training agreements as part of their graduate scheme. You can train for the ACA with a degree in any discipline. It is also possible to start the ACA on your own as an independent student. However, you'll still need to secure a training agreement to acquire the necessary practical work experience.

FINDING AN EMPLOYER TO TRAIN WITH

Accountancy firms are one way to train for the ACA. But you can also train in large companies, small enterprises, charities, government bodies ... the list goes on. There are c5,000 employers globally who you can train for the ACA qualification with.

WHAT IF MY CHOSEN EMPLOYER ISN'T AUTHORISED?


If a particular employer doesn't offer the ACA, it's worth mentioning your desire to train for the qualification. Provided the employer can meet our training standards, the process for them to become authorised to train you is simple, free of charge and can take as little as three weeks.

What can you earn?

If the career opportunities weren't rewarding enough, salaries for trainee and qualified chartered accountants are extremely competitive too.

These are average figures that include qualified chartered accountants with substantial experience. However, even at the start of your career, you can expect to receive an attractive salary.

£30k*

is the average graduate starting salary for Accounting and Professional Services.

£49.9k**

is the average salary for a newly qualified ICAEW Chartered Accountant with 0-2 years' experience.

£110.8k**

is the average salary plus bonus, for ICAEW Chartered Accountants working in business.

What training is needed to complete the ACA?

The ACA is both rigorous and challenging. But that's why our chartered accountants are always in demand.

The ACA qualification combines study and exams with 'on-the-job' experience. This means you'll be based with an employer, doing real work and earning a salary as you train. It typically takes three years to complete the ACA. You'll need to find an authorised employer to support you and enter into a training agreement with them.

The training agreement will outline the support you'll receive during training and will include details about tuition, study leave and mentoring.

In addition to giving you time out of the office to study, employers will pay for your tuition with a dedicated provider and also pay for your exam and student registration fees.

You'll need to successfully complete the ACA qualification before you can apply to become a member of ICAEW.

Once this is approved, you can use the letters ACA after your name and will be recognised as an ICAEW Chartered Accountant.



THERE ARE FOUR ELEMENTS TO ACA TRAINING:

Practical work experience

You need to record 450 days of relevant 'on-the-job' work experience during your period of approved training. If you have completed an internship or placement year with one of our authorised employers, you may be able to count up to 12 months' experience towards your ACA training.

Ethics and professional scepticism

Ethics and professional scepticism are an essential part of being a chartered accountant. You'll follow a structured programme to ensure you apply them - focusing on areas such as integrity, objectivity and independence.

Accountancy, finance and business modules

15 modules, each with its own exam. These modules are staged across three levels: the first introduces you to core concepts; the latter two build on your growing technical knowledge and experience.

Professional development

Demonstrate your competence in seven key professional skills (such as communication, team working and decision making) by providing an example from your work experience.

What is the training and exam schedule?

Your employer will guide you on the pace and order that you complete the modules. There's a lot of flexibility to the ACA. With the exception of the Case Study, which must be attempted last, modules can be taken in any order.

3. WHAT ARE THE ENTRY REQUIREMENTS?

- A strong academic record.
- At least a 2:1 in your degree (the subject isn't important).
- At least two A-levels and three GCSE passes or equivalent.
- A genuine interest in, and commitment to, your chosen career path.
- The ability to stand out from the crowd, and show how you can add value to an organisation.

4. HOW CAN I GET A HEAD START?

ICAEW's Student Scheme (USS) is an online training resource we've created to help you develop the workplace skills that employers want. It also entitles you to study ICAEW CFAB at no extra cost.
